"We are calling because you have fraud on your account, please give me your account information." "You can pay this overdrawn account by taking cash to your nearest BitCoin machine." All these phrases come from fraudsters who want your money.

Remember, THE LOCAL will never call you and ask for your account information. Conversely, if you call THE LOCAL, we may ask challenge questions to verify your identity, but we will never call you to do the same.

Please make a 2025 resolution to be vigilant to scams and know that converting debt to BitCoin or gift cards is a scam. We cannot thank you enough for allowing us to care for your money.
